**This contract is between V24-7ENT and the above named client. A non-refundable deposit(per dancer) is required at the time of contract signing. The deposit may be paid in the form of cash or money order. NO PERSONAL CHECKS.**

**If an entertainer does not show, deposit will be returned for that entertainer. Final payment will be due on the day of the event and prior to performance, in the form of cash only. Pricing is per performance and not set by the hour (5 song maximum). Once at the event, the entertainer will be provided a private room for dressing. Entertainer(s) will provide entertainment for an agreed period of time. This time will begin at the arrival of the entertainer(s).**

**V24-7Ent reserves the right to a 45 minute grace period for the referenced entertainer(s) (i.e. excessive lateness, absence, destruction of property, etc.).**

**If client cancels within 5 days of the event, the client is responsible for balance due + any legal fees (court cost/lawyers) acquired while attempting to collect balance due.**

**1. V24-7 Entertainment must receive accurate and detailed directions to the scheduled event no later than 3 days prior to event.**

**2. If overnight accommodations are required, no motels or inns are accepted. (Except Holiday Inn). The client will provide 2 meals per day.**

**3. Camcorder/and or cameras are NOT permitted unless previous arrangements have been made and are NOT to be used for personal/public use such as internet, retail sales etc.**

**4. No males (gay, bi, or heterosexual) are allowed at the event. No children under the age of 18 are permitted at the event.**

**5. A CD player must be present and accessible for use at time of performance.**

**6. A \$25.00 re-scheduling fee will be applied for any date, time or location change after contract has been signed. Re-scheduling must take place within 30 days of the original event date. Any time longer than 30 days will be considered a cancellation.**
